Based on the *American Medical Association Manual of Style*, 10th ed., 2007. A paper copy is available at the Science Library Reference Desk, call number Sci Ref R119.A533 2007

The list of references should be at the end of your paper. Items in the list of references are in order as they are cited. Use superscript numbers to mark your citations in the body of your paper. No separate bibliography is required.

Note that authors are listed last name, then initials, with no spaces or periods between or after first and middle initials. Search for standard abbreviations for journal names at [www.ncbi.nlm.nih.gov/journals](http://www.ncbi.nlm.nih.gov/journals)

**Journal article, two or more authors:** for up to six authors, include all authors in the order they're listed in the paper; for more than six authors, list the first three authors followed by et al
